## **BONUS to GELD Ratepayers!**

Many of you may notice that the dollar amount for the August 2017 bill is lower than typical for a summer electric bill.



There is a one-time billing credit on your August 31, 2017 which is shown as a rate reduction on the generation portion of your bill. This is because on August 20, GELD received a check in the amount of \$409,649.20. Almost all of this check is due to the fact that the bonds for "Seabrook Project 6" have been reduced to a level that allows for the release of our security deposit.

As part of the bonding for our ownership interest in the Seabrook Nuclear Power Plant, we were required to keep a substantial amount of cash in a bond reserve account until the bond balance reached a certain point. We reached that point in mid-August and GELD received this nice bonus.

At the July 11th Board meeting, the GELD Board voted to disburse the funds as follows: Approximately \$200,000 would be a direct credit to customers on the August 31 bill; \$100,000 would be earmarked for substation investment; \$50,000 would go towards our long-term liabilities to be placed in our OPEB trust account (bringing the trust balance to approximately 69% of the total liability); and the balance would be deposited into GELD's cash account.

The \$200,000 is being distributed based on July's actual kWh sales. Our kWh sales in July were 6,357,831 which determined the credit for this month's bill to be 3.15 cents per kWh. This credit should reduce your August bill by about 23%. The 3.15 cent credit has been applied to the generation rate portion of your bill.

## **Solar Farm Update**

We have a full year of data from our solar farm on the town landfill on Cow Pond Brook Road. We are thrilled to announce a capacity factor of 17.2%. This is higher than anticipated. A capacity factor of 100% would be the result of electric generation operating at capacity 24 hours a day, 365 days a year.

We have had solar contribution during the peak hours of May, June and July saving us nearly \$30,000 in transmission costs over the last three months. 
